

## **Rights and Responsibilities of Students Participating in Research**

As part of your psychology course, you have the opportunity to participate in experiments outside of class through the Psychology Department Subject Pool. By participating, you are contributing to cutting-edge psychological research. Results from these studies help to inform and advance what we currently know about psychology, so it is crucial that you take each experiment seriously and make every effort to provide quality responses during these studies.

Our goal is to make this experience both interesting and educational. By participating, you will better understand current psychological research and how this research is conducted. You will also be providing valuable assistance to the researchers, who depend on your cooperation for the successful completion of their studies. Your time and effort are sincerely appreciated.

The Psychology Department conducts these studies in accordance with the ethical procedures established by the University Research Board and the Department's Human Subjects Committee. If you have moral or ethical concerns with participating in this research, please contact your Instructor for an alternative assignment. Below is a list of rights and responsibilities that you have as a participant in these studies.

### *Rights of Students Participating in Research:*

1. Before each study, you will receive information about the study and possible consequences. This will be in the written consent form. You must read and sign it before beginning the study.
2. If you feel that a study violates your moral, religious, or ethical values, you can withdraw from the study. If you withdraw from a study that is shorter than one hour, you will not receive any credit for the session. The session will be marked as "excused no-show", which will not compromise your account in any way. For studies that are longer than one hour or studies that include multiple sessions, you can receive pro-rated credit for partial completion of the study. The researcher must provide a Voluntary Withdrawal Form, which you must fill out and return to the Subject Pool Coordinator to receive partial credit.
3. All personal and identifiable data collected during these studies will be kept confidential unless you give the researcher permission to do otherwise. Your privacy will be safeguarded.
4. At the end of the study, you will receive a written debriefing. This will include a summary of the research in addition to resources for further information. You may ask questions about the research and can request information about the results and significance of the research.

### *Responsibilities of Students Participating in Research:*

1. You must be 18 years old to participate in psychological research. If you are not 18, see your instructor or the Subject Pool Coordinator for an alternative assignment.
2. You must register for Subject Pool, sign up for studies, and keep track of your appointments using the SONA system, at <http://uiuc.sona-systems.com/>. Make sure to schedule appointments so that you have enough time to get there. You cannot participate in a study if you arrive late.
3. If you need to cancel an appointment before cancellation deadline, do so via your SONA account. If you cancel after the cancellation deadline of a specific study (marked on the study information page and may vary) or miss a study without proper documentation, your session will be marked as unexcused No-Show. If you receive two unexcused No-Shows, your account will be locked. While your account is locked, you will be unable to sign up for studies, although you can still take part in any studies that you have already signed up for and will receive credit for any studies completed thus far. Your account can be unlocked after you have completed additional online ethics training at <https://www.citiprogram.org/>. If you have more than 4 unexcused no-shows, your account will be permanently locked and you will not

be able to earn any further SONA participation credits to fulfill course requirements. For detailed instructions on how to unlock your account, please refer to the FAQ for students.

4. You are expected to follow instructions and avoid creating disruptions during the study. You should be respectful, take each study seriously, and make an effort to give quality responses. If you are being disruptive, purposely providing inaccurate or inappropriate responses, or acting in a manner which makes the researcher believe that your data will be unusable, you will be asked to leave and will not receive any credit for the session. The session will be marked as unexcused no-show.
